The criteria for applying for a clinical position are:

1. **First Year Courses**: All first year courses must be completed successfully by the end of the semester in which you are applying. Successful completion requires a C- or better for general education courses and a C or better for all HPNU courses.

2. Minimum GPA: The cumulative GPA must be 3.0 or higher at the end of the semester of application. Included in the GPA calculation is all previous college coursework in addition to the courses taken at UCCS.

3. Current Active Students: Applicants must be active at UCCS, and must have successfully completed at least one course at UCCS over the three semesters prior to taking the exam (spring, Fall or Summer semester).

4. BSN Applicant Notification of the Undergraduate Nursing Dress Code Policy: The

Department of Nursing welcomes and encourages all eligible applicants to apply to the UCCS nursing program. Our nursing program includes campus classroom settings, campus simulation labs, and clinical agency placement requirements. Students assigned to any clinical placement site or experience associated with the UCCS nursing program must abide by the Nursing Department Dress Code policy as well as that clinical site or agency's professional attire rules.
